5. Removal of rocks, debris, clay, stumps or tree roots (May require customer to hire a separate contractor)
6. Backfill dirt, or removal of or spreading of dirt from pool site
7. Landscaping or back-filling
8. Removal of pool boxes/cartons
9. Ladder or entry system assembly
